With reference to your application dated 30.11 and subsequent
correspondence with the school/inspection in this regard, I convey
the grant for provisional recognition to the Shri Jain Er. Sec. School Bikaner (name of the
school with address) for Class I to Class V for a period of
three years w.e. 2012-13 to 2015-16

The above sanction is subject to fulfillment of the following
conditions:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The School shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (Central Act No. 35 of 2009) and the Rajasthan Right of Children to Free and Compulsory Education Rules, 2011.
3. The School shall admit in class I or in pre-school class, as the case may be, to the extent as per the Act of 2009, of the strength of that class, children belonging to weaker section and

disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion.

4. For the children referred to in paragraph 3, the School shall be reimbursed in accordance with the provisions of the Rajasthan Right of Children to Free and Compulsory Education Rules, 2011. To receive such reimbursements the school shall maintain a separate bank account.

5. The Society/School shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.

6. The School shall not deny admission to any child for lack of proof of age and shall adhere to the provisions of section 15 of the Act of 2009. The School shall ensure:

(i) No child admitted to the school shall be held back in any class or expelled from school till the completion of elementary education in the school;

(ii) No child shall be subjected to physical punishment or mental harassment;

(iii) No child shall be required to pass any Board examination till the completion of elementary education;

(iv) Every child completing elementary education shall be awarded a certificate as laid down under rule 23 of the Rajasthan Right of Children to Free and Compulsory Education Rules, 2011;

(v) Inclusion of students with disabilities/special needs as per the provisions of the Act of 2009;

(vi) The teachers are recruited with minimum qualifications as laid under sub-section (1) of section 23 of the Act of 2009;

Provided that the current teachers who, at the commencement of the Act of 2009 do not possess minimum qualifications, shall acquire such minimum qualifications within a period of 5 years, as per the provisions of the proviso to section 23 of the Act of 2009;

- (vii) The teachers performs their duties specified under sub-section (1) of section 24 of the Act of 2009; and
- (viii) The teachers shall not engage himself or herself for private teaching activities.

7. The School shall follow the syllabus on the basis of the curriculum laid down by the appropriate authority.

8. The School shall maintain the standards and norms of the school as specified in section 19 of the Act of 2009. The facilities reported at the time of last inspection are as given under:-

11. The School is run by a society registered under the Societies Registration Act, 1860 (Central Act No. 21 of 1860), the Rajasthan Societies Registration Act, 1958 (Act No. 28 of 1958), or a public trust constituted under any law for the time being in force;

12. The School is not run for profit to any individual, group or association of individuals or any other persons;

13. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared




14. The recognition Code Number allotted to your school is 192/10/72-72
